The ISMG Patrol Officer will give specific emphases on OLP residents who have subscribed to daily patrol service. In the event of your alarm sounding, ISMG will respond to the resident's property to inspect and report any and all activity at your home. ISMG can also be listed with your alarm company as the first contact should your alarm activate and while ISMG is on duty we will provide immediate response to your residence.
- Our dispatch center will make phone contact with your responsible party should we find anything negative on your property. We will also forward the incident of the activity to your email address on file.

*ISMG will be working toward 24/7 patrol service. This will not be in effect until we receive the proper amount of subscribers.

PATROL II: Monthly Investment: \$185.00

- Uniformed Armed ISMG Patrol Officer will patrol client's property daily in a random patrol fashion. The ISMG Patrol Officer will give specific emphases on OLP residents who have subscribed to daily patrol service. In the event of your alarm sounding, ISMG will respond to the resident's property to inspect and report any and all activity at your home. ISMG can also be listed with your alarm company as the first contact should your alarm be activate and while ISMG is on duty, we will provide immediate response to your residence.
- In addition the patrol officer will make bi-weekly patrol visits to your residence, physically checking the exterior of your residence, checking doors, windows, gates and any other items which the homeowner has requested.
- Should the patrol officer locate any issues while on property, our dispatch center will make phone notification to the responsible party listed by the homeowner. We have the ability to take photos and document any issues we locate, which will then be forwarded to the email address provided by the homeowner.
